Will need to provide proof of ID.</p> <p><b>Is there reason to believe the applicant has a priority need?</b></p> <p><u>Yes, reason to believe</u> – Client has a diagnosis of autism, has high support needs, and appears very vulnerable whilst on the streets.</p> <p><b>Is there a duty to provide interim temporary accommodation under s188?</b></p> <p><u>Yes</u> once homelessness, and eligibility is confirmed.</p>
